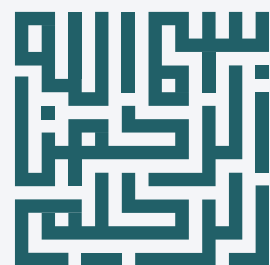

A/ Technical Requirements





1. Coaches

- 1.1 Coaches must obtain basketball training certificates to be approved by the Saudi Basketball Federation for all grades and provide the federation with a copy thereof.
- 1.2 The male and female coaches or any of the club's staff must have a first aid certificate or obtain it during the first three months after contracting with the club and providing the federation with an enclosed copy.
The coach may obtain the first aid certificate from the Leaders Development Institute
- 1.3 One coach shall be designated for every 15 players. If there are more than 15 players, an assistant coach must be assigned.
- 1.4 Provide the Federation with a certificate of good conduct from any accredited center for coaches.



2. Facilities

2.1 The court must be indoor (halls) pursuant to the standards and criteria of the International Basketball Federation: 28 mx 15 m (91.9 ft x 49.2 ft) - if it is owned or rented facility.

* Private clubs players may train in outdoor fields pursuant to the standards and criteria of the International Basketball Federation: 28m x 15m (91.9 feet x 49.2 feet) - if it is owned or rented facility.

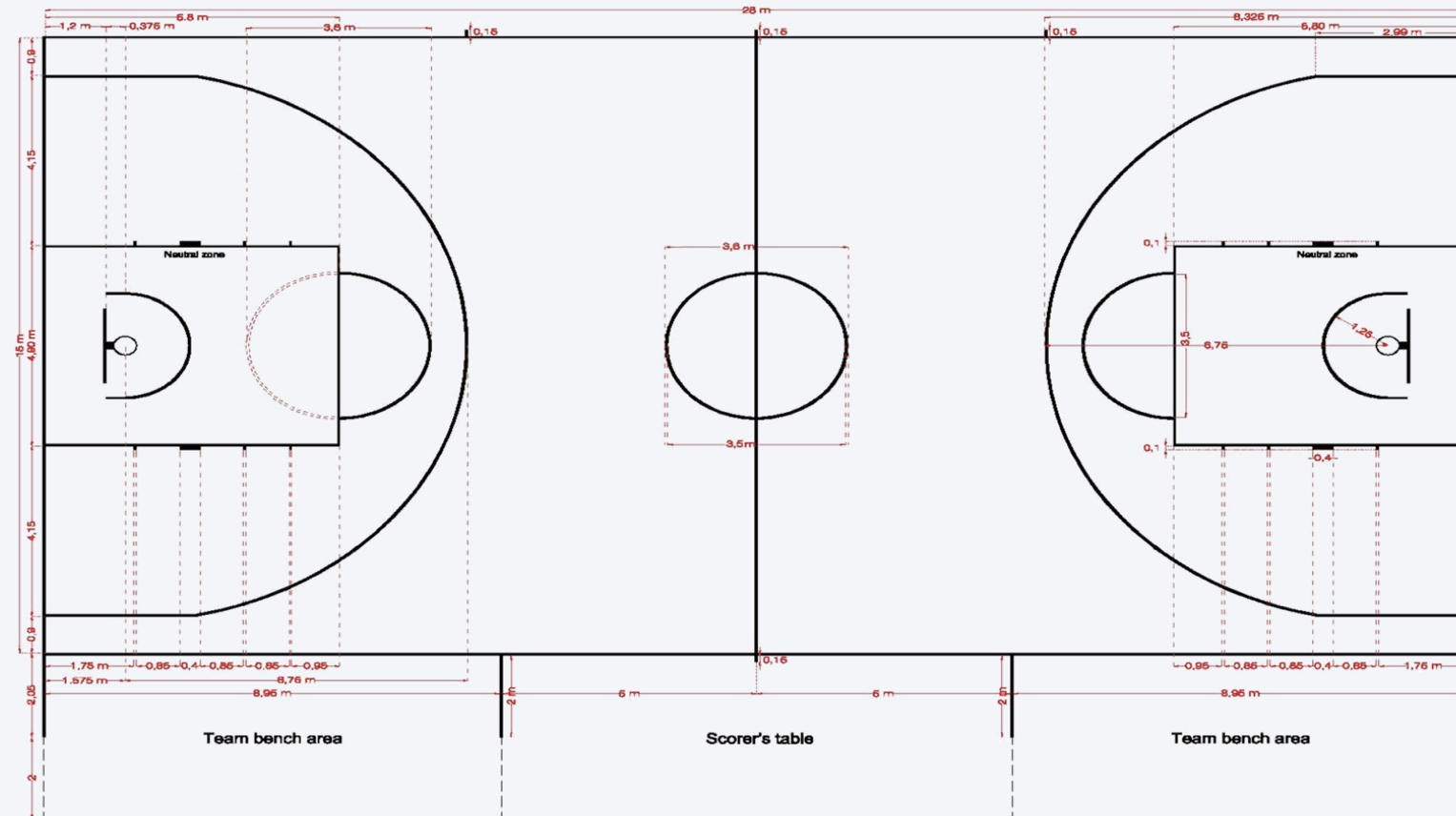

2. Facilities

2.4 The Padding must be in accordance to the International Basketball Federation standards (Appendix B).

2.5 The Basketball ring: The rings shall be made of solid steel. Have an inside diameter of a minimum of 46 cm and be in the center of the backboard (horizontal).

The top edge of each ring shall be positioned horizontally, 3,050 mm equidistant from the 2 vertical edges of the backboard.

2.6 Backboard: The backboards shall measure 1.8m x 1.05m - the backboards shall be made with a thickness of minimum 19mm, 1.2m from finish line.

* The backboards shall be made of non-reflective laminated safety glass or tempered glass with a flat front surface and shall:

- ❖ Have a protective framework of the backboard support structure around the outer edge.
- ❖ Be manufactured as shatter-resistant glass.

2.7 The following must be in accordance with the International Basketball Federation requirements:

- ❖ Two dressing rooms with their own rest rooms.
- ❖ Restrooms on the site (for female and male visitors) and for people with special needs.
- ❖ A Spectator area with a capacity of no less than 200 spectators in the second and first class, 500 spectators in the premier division.
- ❖ Medical clinic.

2.8 An electronic scoreboard and a game clock control panel pursuant to the picture in Appendix C.

2.9 Shot clock shall be placed on the two towers or on the sides of the court.

The International Basketball Federation certifies the Molten ball.

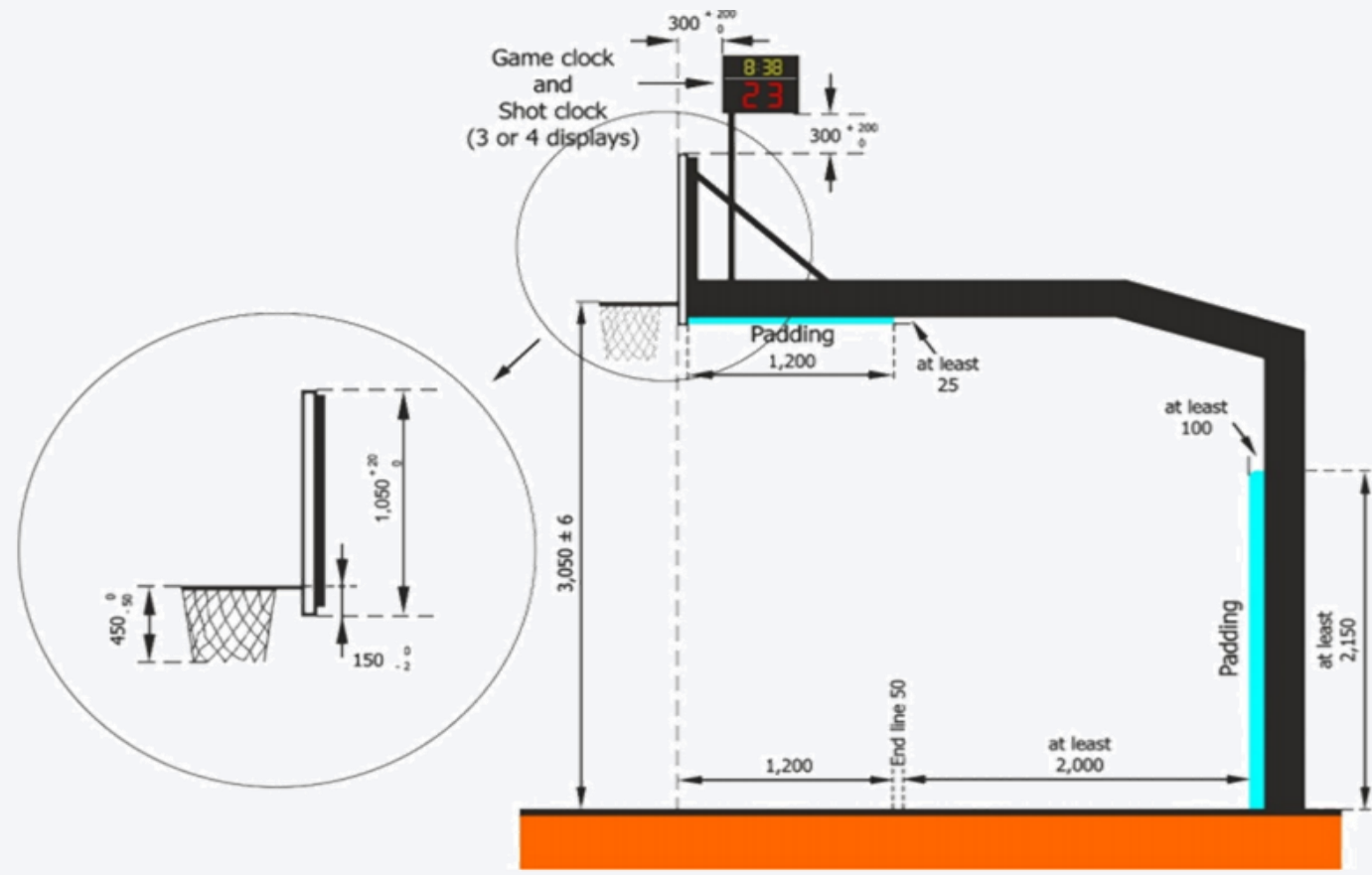
Number of Players

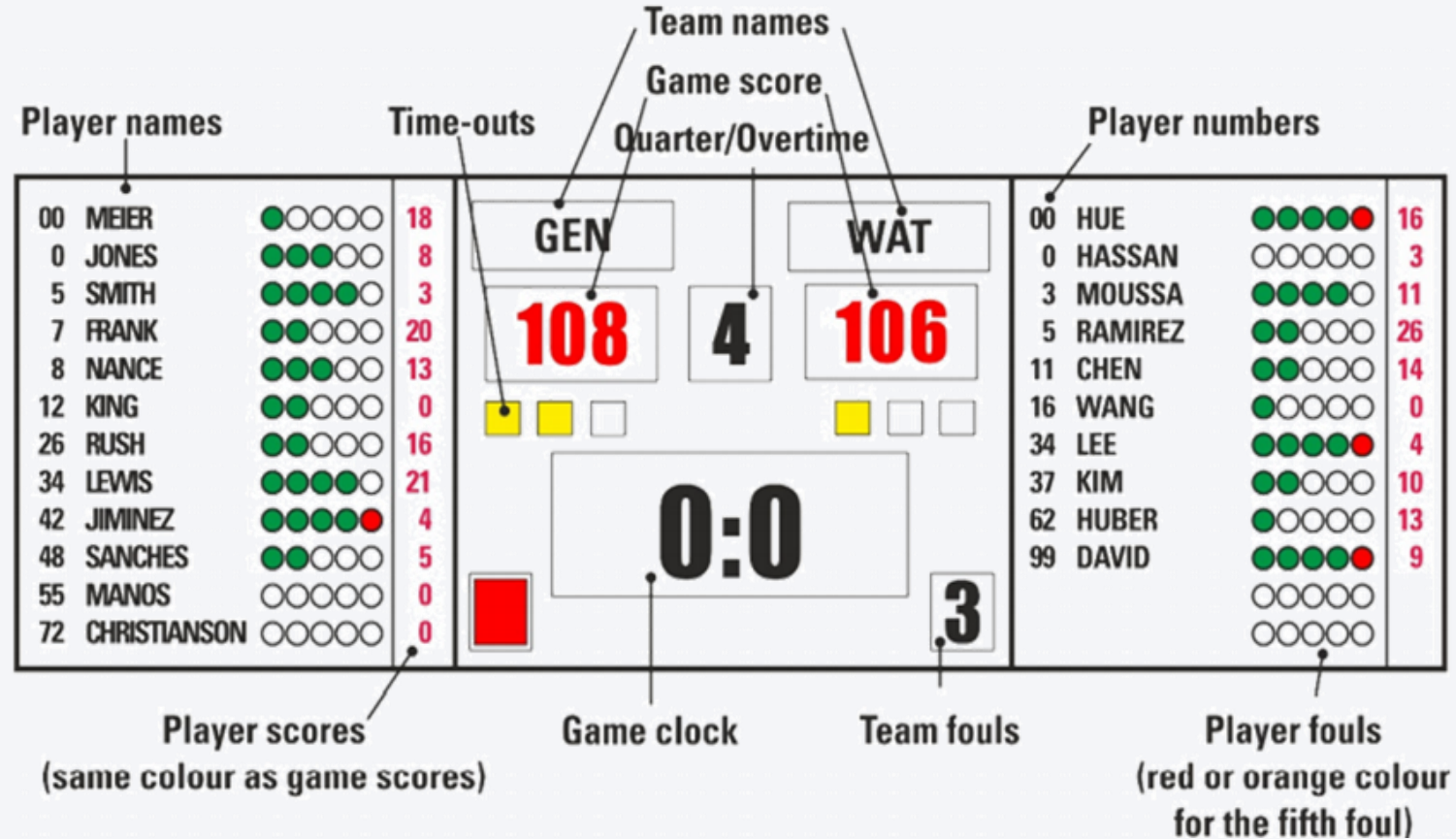
Basket Base

4. Safety

- 4.1 The facility must adhere to the health regulations and protocols promulgated by the Ministry of Health, the Ministry of Sports and the Saudi Basketball Federation.
- 4.2 The federation shall inspect the safety of the entire basketball court (every 3 months) to ensure that there are no hazards that could cause damage and keep reports.
- 4.3 Conduct maintenance of the facility and inspect the safety devices periodically or in the case of any damage has been occurred to ensure that the facility remains safe.
- 4.4 Players shall not be obligated to play more than 20 hours per week.
- 4.5 Upon acceptance of the player, the player is required to submit a medical examination stating that the participant is medically fit and the club is held the full responsibility for that.

4. Safety

4.6 Having a certified physiotherapist for the team or a valid contract with a clinic from the Saudi Federation for Health Specialties.

5. Competition

- 5.1** Adhere to the terms and the statute of the various federation competitions for all divisions (to be sent to clubs prior to the start of the sports season).
- 5.2** Participate in competitions organized by the Federation.
- 5.3** The club shall provide the certified name, logo and the sport jersey of the Federation.
- 5.4** All teams shall accept match broadcasts by the Federation.
- 5.5** Advertisement and sponsorship - The Federation has the right to place its sponsorship on the court and the team's sponsors on the walls and pitches in the professional league, (if the matches are taking place at the club's court)
- 5.6** Number of teams participating in competitions:

5. Competition

- 5.7** The last two teams ranked ninth and tenth in the professional division will be relegated to the first division, and the top two teams ranked first and second in the first division will be promoted to the professional division next season.
- 5.8** The last two teams ranked ninth and tenth in the first division will be relegated to the second division, and the top two teams ranked first and second in the second division will be promoted to the first division next season.
- For more details, please refer to the Technical and Competitions Committee Regulations.
- 5.9** The Saudi Arabian Olympic Committee and Federations issues the conditions and instructions regulating the internal and external participations, whether in training camps, tournaments or competitions, and circulates them to the sports federations to work in accordance with them.

B/ Administrative Requirements





6. Membership

- 6.1** To obtain membership in the federation, the club must submit an application to the Saudi Basketball Federation two months before the start of the season with the following attachments:
- ❖ A statement of the names, qualifications and experiences of the technical and supervisors team of the game.
 - ❖ A statement including the existing facilities, stadiums and equipment
 - ❖ A pledge of compliance with the regulations, decisions and regulations promulgated by the Federation.
 - ❖ Males - Receipt of the prescribed fees payment for joining the federation's membership, which is 10,000 riyals (ten thousand Saudi riyals)
 - ❖ Females - Receipt of the prescribed fees payment for joining the federation's membership, which is 5,000 riyals (five thousand Saudi riyals)

It is thereby activated after obtaining the commercial registration from the Ministry of Commerce and the licensing from the Ministry of Sports.

6.2 The board of directors of the federation shall review the request and issue its decision within 30 (thirty) days from the commencement date on which the request was submitted by the general secretariat of the federation.

6.3 The Saudi Basketball Federation investigates and confirms the technical requirements.



6. Membership

6.4 The applicant shall be notified of the decision of the Board of Directors within fifteen days from the date of approval on the address included in the joining application, and the Ministry shall provide a copy of the decision.

*** An applicant for membership is considered a member of the Federation from the date of the decision issuance by the Board of Directors.**

6.5 In the event that the application by the board of directors is rejected, the decision must be justified, and the membership applicant has the right to appeal the decision to the Ministry within 15 days from the date on which he is informed of the decision, and its decision is considered as a final settlement.

6.6 If the membership applicant is not notified of the decision of the board of directors officially during the periods referred to in the aforementioned paragraphs, then he has the right to elevate the matter to the Ministry to take the final decision within thirty days of its receipt
