A/ Technical Requirements







1. Coaches

- 1.1 Register on the Saudi Esports Federation platform, and the club adds them to each game in which the club registers and accredits coaches to the Saudi Esports Federation. The player can be a coach whenever he is eligible.
- 1.2 Be at least 18 years old.
- 1.3 Be a former player or have experience in Esports for at least six months, and the estimate of the duration of experience and its adequacy is subject to the discretion of the Saudi Esports Federation as it deems appropriate.
- 1.4 Be mentally, physically, and medically fit.
- **1.5** Demonstrate good conduct and behavior.





2. Facilities

2.1 Attach the ownership deed or lease agreement for a headquarters (administrative office) during its registration with the Saudi Esports Federation, provided the club name registered in the commercial register.





3. Equipment

3.1 None





4. Safety

- 4.1 The academy shall require the player to submit a **medical report** confirming that the participant is medically fit. The academy shall assume full responsibility for this requirement.

 - Then, the hospital/clinic shall complete the following form from the Saudi Federation of Sports Medicine: http://sfsm.org.sa/mos10
- 4.2 **First Aid** The club shall provide a first aid kit and adequate equipment during matches and training sessions, as specified in the following link: http://sfsm.org.sa/mos70, in accordance with the standards of the Saudi Federation of Sports Medicine.

- 4.3 A fire alarm system in compliance with the conditions and requirements of Civil Defense shall be installed.





5. Competition

- 5.1 The Saudi Olympic & Paralympic Committee shall issue the requirements and instructions governing both domestic and international participations, whether in relation to camps, tournaments, or competitions, and shall circulate them to the sports federations for implementation.
- 5.2 Participation in leagues and tournaments organized by the Federation shall be as per the type of each tournament and game.
- 5.3 The Saudi Esports Federation shall have the right to supervise and control the activities of esports academies in competitions, tournaments, or any other activities organized or hosted by the Federation.

6. Membership (Registration)

- **6.1** The club shall complete the licensing procedure to obtain final approval and must submit the register application to the Saudi Esports Federation (SEF) via the platform saudiesports.sa . the SEF shall review the application and ensure that it is completed and decided upon within a period not exceeding thirty (30) days from the date of receipt the application, provided that the application includes the following:
- **6.1.1** a copy of the ownership deed or lease agreement for the club premises with the name entered in the club's commercial register.
- **6.1.2** a copy of the national ID for the representative of the club.
- **6.1.3** a copy of the national ID of the regular representative of the club.
- **6.1.4** Specify the official e-mail for communication with the club with appoint the contact person, and attach his name, contact number, position, and powers in the registered club.
- **6.1.5** Provide the club's organizational structure, including, at minimum, the Chairman and an administrative officer.
- **6.1.6** Attach the club license from the Ministry of sports (NAFES).
- **6.2** The club the applicant for registration-acknowledges the following obligations:
- **6.2.1** Commitment to good participation and representation in local, regional, continental and international Esports tournaments.
- **6.2.2** Commitment to the participation of the selected players in the preparation programs and official participations of the national teams.
- **6.2.3** Commitment to participate in the Saudi Esports league (SEL).
- **6.2.4** Comply with any requests from SEF to provide documents and information or complete deficiencies if requested by the SEF, within a maximum 10 working days.





6. Membership (Registration)

- **6.2.5** Compliance with the SEF orders during inspections for the licensed club.
- **6.2.6** Commitment to the correctness of any information or documents provided by the licensee to the SEF under which he obtained the license.
- **6.2.7** Commitment to work to achieve the objectives of the SEF and not harms its entity or its reputation.
- **6.2.8** The club page is updated periodically and includes information on registered games, achievements in the game, players' information, coaches and team administrators.
- **6.2.9** The obligation to register player contracts with the unified contract for professional players.
- **6.2.10** Compliance with the statutes, regulations and decisions issued by the Saudi Esports Federation.
- **6.2.11** Compliance with the rules of each game, including the rules issued by the publisher.
- **6.2.12** Acknowledge that contractual disputes and disciplinary complaints are referred to the competent judicial committees of the Saudi Esports Federation.
- **6.1.7** The applicant is notified of the SEF decision.
- **6.1.8** If the application refused, the decision must be reasoned.





7. Fees

7.1 None.





8. Violations & Penalties

8.1 These are the violations and penalties that may be imposed in case of non-compliance with the regulations of the Saudi Esports Federation and the Ministry of Sports, including the discipline regulation, the regulation of the Saudi eleague, the professionalism regulation of Esports Players, and the schedule of violations and sanctions for private sports clubs issued by the Ministry of Sports.
