A/ Technical Requirements



#### 1. Coaches



#### 1. Coaches

- **1.1** Obtain "Training of Trainers (TOT)" certificate.
- **1.2** Provide a minimum of 3 coaches and 3 assistants
- **1.3** Require high level of fitness and ability to train.
- **1.4** Experience of not less than 3 years in the same field
- **1.5** The club must provide at least one technician.



#### 2. Facilities



#### 2. Facilities

- 2.1 Provide wireless sports arenas and fields (RC Robots RC planes RC cars RC boats, or collectively)
- 2.2 If the club includes wireless planes sport, it must be regulated pursuant to the requirements of the concerned authority.
- 2.3 The facility shall be not less than 1000 square meters, and it must have at least 6 basic arenas (Off-Road RC cars RC Soccer Robot RC crawler car RC Drifting Cars RC Planes Runway mini SUV cars).



#### 3. Equipment



#### 3. Equipment

- **3.1** Provide all types of wireless sports arenas.
- 3.2 Provide a runway for RC planes pursuant to the requirements of the federation and the concerned authority which is responsible for licensing the activity in the Kingdom.







#### 4. Safety

- 4.1 Provide at least 1 security guard and safety officer.
- **4.2** Follow the wireless sports safety and security regulations, which include all details in this regard: <a href="https://drive.google.com/file/d/1wVsTnklFVYiYhZOKHHiYADNInC9C">https://drive.google.com/file/d/1wVsTnklFVYiYhZOKHHiYADNInC9C</a> Nxu/view?usp=sharing
- **4.3** Upon acceptance of the player, the player is required to submit a medical examination stating that the participant is medically fit, and the club is held the full responsibility for that.
  - To obtain it, the player shall fill out the following form: <a href="https://forms.gle/xmjjJcdSnauVsWX5A">https://forms.gle/xmjjJcdSnauVsWX5A</a>

- **4.4** Provide a physiotherapist for the team or have a contract with a clinic with a valid classification from the Saudi Commission for Health Specialties. #### 5. Competition

- **5.1** Each tournament has specified regulations and requirements according to the sport discipline and said regulations and requirements are determined by the Federation.
- 5.2 No participation fee in Federation's tournaments and events is required.
- **5.3** The Federation's competitions and events include: (RC Planes competition RC Cars competition Robot competitions RC Boats competitions Wireless Sports Tournaments), and the club shall participate in these competitions according to the type of its membership (e.g. RC Cars membership cannot be used to participate in RC Planes competitions).

# B/ Administrative Requirements







#### 6. Membership

**6.1** To obtain membership in the Federation, the club must apply to the Federation two months before the start of the season with the following attachments:

#### A statement o of the names, qualifications and experiences of the game's technicians and supervisors' team.

- A statement including the existing facilities, stadiums and equipment
- \*A pledge of compliance with the regulations, decisions and regulations promulgated by the Federation.
- \*Receipt of the prescribed fees payment for joining the federation's membership,
- It is thereby activated after obtaining the commercial registration from the Ministry of Commerce and the licensing from the Ministry of Sports.
- **6.2** The Federation's board of directors shall review the request and issue its decision within 30 (thirty) days from the commencement date on which the request was submitted by the general secretariat of the federation.
- **6.3** The Saudi Basketball Federation investigates and confirms the technical requirements.





#### 6. Membership

- **6.4** The applicant shall be notified of the decision of the Board of Directors within (15) fifteen days from the date of approval on the address included in the joining application, and the Ministry shall provide a copy of the decision.
- **6.5** If the application is rejected by the Federation's board of directors, the decision must be justified, and the applicant has the right to appeal.
- **6.6** If the applicant for membership is not officially informed of the Federation's board of director's decision during said periods, the applicant is entitled to submit the order to the Ministry for final decision within two days of the notification.
- \* An applicant for membership is considered a member of the Federation from the date of the decision issuance by the Board of Directors.



#### 6. Membership

#### **6.7 Player's Registration**

- \*The club shall apply for the membership according to the form approved by the federation.
- ❖The club shall have a valid membership.

#### **6.9 Membership regulations**

- **6.9.1** The minimum age of player to be eligible to participate is 8 years old Obtain the parental written consent for participants under the age of 18 Provide a copy of the national identity card and family card for those under the age of 18.
- **6.9.2** Follow the specified requirements for RC Boats and RC Planes: Provide Criminal Record certificate for participants over the age of 18, with an exception of females and military officers (Provide a valid military ID card)

#### 7. Fees

(5.000 SR) five thousand Saudi riyals annually (subject to change)





#### 8. Violations & Penalties

- **8.1** The club shall not adopt a name or a slogan that may lead to confusion with other teams or any other club.
- **8.2** The club shall not change the team's colors or add colors or make any amendment without the consent of the Chairman of the Board.
- **8.3** The club's name and emblem shall be approved by the Federation.
- **8.4** The club shall not neglect to comply with or abide by any resolution, notice, and circulars promulgated by the Federation, or fail to implement decisions or requests issued by the judicial authorities.
- **8.5** The club has no right to conduct any negotiations or contact any individuals or bodies, external or internal, except if the club obtains the federation approval.
- **8.6** The club shall not send any representative to execute any external mission without the approval of the Federation.
- 8.7 The club has no right to withdraw from official competitions and tournaments.
- **8.8** The club shall not participate in any internal or external activities or events without the approval of the Federation.





#### 8. Violations & Penalties

#### **8.9 General Provisions**:

- **8.9.1** The club's license shall not be renewed if the club has not participated in 3 consecutive or 6 separate tournaments during the year.
